



TRAINING AGREEMENT

Name of Enterprise, hereinafter referred to as "The Driving School" agrees to provide applicant, hereinafter referred to as "Student", 24 hours of theory (classroom or virtual) and/or 8 hours of behind-the-wheel training, whichever is applicable as indicated above, based on the Ohio Driver Training Curriculum. State of Ohio regulations require The Driving School to make available all training by 6 months from the start of your in Classes.

Should a student be unable to attend available training sessions offered, the school is relieved of the aforementioned obligation. The 24 hours of theory must be completed prior to beginning the behind-the-wheel training. Regulations prohibit more than four hours of training to be conducted in one day. The Driving School shall furnish a licensed instructor and a motor vehicle for instruction. The tuition for said instruction is \$ 420.00.

Any additional classroom training that the Student chooses to procure shall be furnished at the rate of \$ 70.00 per hour. Additional in-car training may be obtained at the hourly rate of \$ 75.00. Student, upon the approval of The Driving School, may, for an additional fee of \$ 95.00 use the Driving School's vehicle to take a driving exam at a State exam center located in 180.00 County, OH.

The Driving School may loan the Student a textbook for use during enrollment at the Driving School. A fee of \$ 50.00 will be charged for any book not returned or returned damaged.

The Student may begin classroom instruction, at age 15 years and 5 months, before obtaining a temporary driving permit. However, the Student is required to obtain a valid temporary driving permit and pay tuition in full prior to scheduling the practical driving portion of the training. If the Student must cancel a scheduled driving appointment, cancellation must be made at least 24 hours prior to the scheduled appointment. Failure to do so may result in an additional fee of \$ 75.00. The same fee shall apply should the Student fail to appear for, or for any reason not be prepared to take, the scheduled lesson. The Driving School reserves the right to deny the Student admittance to any class if the Student is tardy. Should a check received as payment of tuition in whole or in part, be returned due to insufficient funds, the Student may be removed from driving schedule until such check is made good. An additional fee may be charged for any returned check.

The Student is required to complete all available training within six months of the date the training begins. There may be no refunds provided after that time. Upon expiration of this agreement, a reinstatement fee may be charged before any further services are provided. The Driving School does not guarantee the issuance of a driver's license to the student. If training is not completed within the six months, a new agreement shall be established and training shall be restarted.

The Driving School reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by The Driving School to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any tobacco product, alcohol, or drug of abuse is strictly prohibited. Should this agreement be cancelled under such circumstances, all fees may be pro-rated, based upon hours of services provided prior to cancellation.

Refund Policy: Student further agrees to buy \$20.00 of gasoline for the company vehicle during ONE in car lesson. Please be aware that the driver's education vehicles are equipped with video surveillance, and by signing below, you consent to the use of this surveillance. If the student must cancel the lesson prior to the start of their in car lesson due to an illness, the student will not be able to reschedule their lesson until a doctor's letter, on their letterhead, confirms the student is safe to continue their scheduled lessons. All students must have completed their online (self-paced) or Zoom/Live course as of May 1, 2022 in order to begin the behind the wheel lessons per the Ohio Revised Code. Student temporary permit paper printout from the BMV must be within the first 60 days of issuance in order to do your behind the wheel lessons. The Temporary permit is still valid for a year, but you must have a new issue date that does not exceed 60 days from the issuance for all of your behind the wheel lessons. Pictures of the temporary permit are not allowed; the student must have the actual hard copy including or the temporary permit letter, not to exceed the 60 day law, on their person, for all behind the wheel lessons. Student further agrees to place their cell phone in the glove compartment for the duration of each behind the wheel lesson, to prevent any distractions in the drivers education vehicle. Should the student be tardy by 15 minutes or more of their scheduled lesson, the student agrees to pay the cancellation fee prior to rescheduling that missed lesson. The final road test at the Ohio Driving Testing Center must be scheduled at least 1 week from your last behind the wheel in car lesson which will allow us to email you, your completion certificate and no certificate will be issued if there is an active balance on the student's account. Should the student be involved in a collision while in the driving school vehicle, a police report must be made and any citation issued is the sole responsibility of the student, or parent of the student, and the student will not hold the driving school liable for any injury that may arise under these circumstances or fees arising as a result of the issuance of that citation. Please make sure to complete ALL of your in class lessons within 3 months of your start date in order to get you scheduled for your behind the the wheel lessons before your 6-month deadline. Should the student or parent request an expedited certificate after the last behind the wheel lesson, the cost for expediting the certificate shall be 50.00 for a certificate issued on a Friday, Sunday, Calendar Specific Holiday, or within 24 hours after the completion of their behind the wheel lesson. No certificates will be issued on a Saturday.

The Driving School shall furnish a certificate of completion to all students under the age of eighteen years, who successfully complete the course. Completion, as defined by the State of Ohio, refers to the completion of the required number of hours, the student's good faith effort having been exercised during the practical driving portion, and the attainment of a score equal to or greater than 75% on the performance measurement. Should Student fail to achieve the minimum passing score on the final exam additional classroom attendance may be required.
